With 30 national titles, 43 runner-up and 43 third place finishes since 1981, as well as nearly two-thirds of student-athlete's posting GPAs of 3.0 or better, UCSD's competitive competence is clear, both in and out of the classroom. As a group, Triton student-athletes consistently maintain a cumulative GPA higher than that of the student body at large. A testament to its combined proficiency in athletics and academics is that for the past four years UCSD has been No. 1 in the National Collegiate Scouting Association's Division II Power Rankings that rate competitive achievement, academic prowess and graduation rate.
